My law practice is 90% criminal law and 10% juvenile law.

As an Assistant District Attorney General (ADA) in the 17<sup>th</sup> Judicial District, I have tried approximately 50 jury trials. The cases I have tried range from "A" felonies to misdemeanors. These cases include, but are not limited to: aggravated child abuse; neglect and endangerment; especially aggravated kidnapping; aggravated robbery; aggravated assault; possession to sell and deliver controlled substances; statutory rape; theft; violation of sex offender registration act; forgery; failure to appear; escape; and harassment. I have in-depth experience in all levels of the Court including Circuit, General Sessions, Juvenile Court and Child Support. In addition to the jury trials I have prosecuted, I have conducted countless bench trials, preliminary hearings, various and numerous motion hearings including, but not limited to, suppression hearings; motions to dismiss; sentencing hearings; and contempt hearings. The trials I have prosecuted are a matter of public record. I have worked in all four (4) counties in the 17<sup>th</sup> Judicial District and have good, sound, respected working relations with each of the Courts, legal systems, and law enforcement agencies in the District. I am in court prosecuting cases at least four (4) days a week in at least three (3) of the counties in the District.

A sample of types of cases I have handled include:

*State of Tennessee v. Jimmy Lee Whitmire.* The defendant held a woman at knifepoint in her home until she was able to contact the police. For these actions, Mr. Whitmire was convicted by a jury of especially aggravated kidnapping; aggravated assault; and aggravated burglary. He was sentenced to eighteen (18) years at one hundred percent (100%) for the especially aggravated kidnapping conviction. He also received two (2) five (5) year sentences at thirty percent (30%) for the aggravated assault and aggravated burglary convictions to be served concurrently to the previous sentence for an effective sentence of eighteen (18) years. Mr. Whitmore appealed. The Court of Criminal Appeals affirmed the trial court's judgments, but modified the sentence to fifteen (15) years for the especially aggravated kidnapping.

*State of Tennessee v. Clayton Wilburn Eslick.* The defendant wrote a series of worthless checks for over \$90,000.00. For these actions, Mr. Eslick was convicted by a jury of six (6) counts of passing worthless checks. He received a sentence of six (6) years from the trial court and a fine of \$60,000.00 from the jury. Mr. Eslick appealed. The Court of Criminal Appeals affirmed the trial court's judgments.

*State of Tennessee v. Wesley Paul Jedlicka.* The defendant, a juvenile, stabbed Jerry Watterson nine (9) times. Mr. Jedlicka was initially charged as a minor in the Juvenile Court of Marshall County. I successfully petitioned the Juvenile Court of Marshall County to transfer Mr. Jedlicka to the Circuit Court of Marshall County to be tried as an adult. He was held on a \$100,000.00 bond and he pled guilty to aggravated assault.

As an employee of the 17<sup>th</sup> Judicial District, we do not handle appeals. All appeals, etc. are handled by the Tennessee Attorney General's Office.

I have been the defendant in two (2) cases. They are as follows:

1. Charles William Young, Jr. vs. Leslie Helton, individually and in his capacity as Sheriff of Marshall County, Tennessee, et al.; CV11,656 Marshall County, TN; Honorable Lee Russell, presiding. Case was dismissed on April 4, 1995. A copy of the Order of Dismissal is attached.

This case was filed while I was with the Marshall County Sheriff's Department and working as a correctional officer. Mr. Young was arrested and brought to the jail. He was placed in a holding cell and while there attempted suicide by cutting his wrist. He was transported to Marshall County Medical Center for treatment. While there he was evaluated by the crisis team and when he was released he was sent to Middle Tennessee Mental Health. Upon his release from Tennessee Mental Health, he was returned to the custody of the Sheriff's Department and placed in a holding cell. While detained at the jail, he stated while at Middle Tennessee Mental Health another patient had assaulted him with a metal dinner tray strike to his mid-section. He complained of pain from this assault. He was released from the jail on his own recognizance. He sued the Sheriff's Department alleging he was denied medical treatment at the jail.

2. Eddins vs. Summers, et al; CV4:99-cv-00102; Honorable R. Allan Edgar, presiding. Case was dismissed on January 10, 2000. A copy of the Pacer History is attached.

Mr. Eddins was charged with passing worthless checks in the General Sessions Court of Lincoln County. I made a plea agreement with him. He agreed to pay the check and the court cost. Once



he paid these amounts, the charge would be retired. He later sued me claiming I denied him his right to be prosecuted.

**ESSAYS/PERSONAL STATEMENTS**

35. What are your reasons for seeking this position? *(150 words or less)*

I believe this position is the next logical step in my life of public service. I was a sworn peace officer as an MP (Army) and as a Deputy (Marshall County Sheriff's Department). I have served as an ADA for the 17<sup>th</sup> Judicial District for 14 years. I hold myself to the highest ethical standards and strive to diligently conduct myself with integrity and honor while prosecuting and upholding the law. I believe the bench is a position which should be held by a person with qualifications that relate directly to the job at hand. I believe a judge should possess enough life experiences to provide the citizens (who come before the Court and expect its protections) with a grounded and reasoned approach to the resolution of issues which affect the community as a whole. I am seeking this position, because I believe I am that person.

36. State any achievements or activities in which you have been involved which demonstrate your commitment to equal justice under the law; include here a discussion of your pro bono service throughout your time as a licensed attorney. *(150 words or less)*

As an ADA, I am required by the State of Tennessee to provide equal and fair treatment to victims and defendants. My job requires me to be impartial and objective to uphold the law. A judicial position would simply be a natural extension of my personal and professional commitment to equal justice. My employment agreement with the State of Tennessee does not allow me to practice law outside of my position as a prosecutor. Therefore, I am not allowed to participate in *pro bono* work while carrying out my duties as an ADA. However, while deployed and under the employment of the United States Army, I have done *pro bono* work for soldiers in the realm of writing wills; reviewing contracts; giving advice on real property matters, child support and custody issues; and successfully defended enlisted personnel at reduction/dismissal hearing.

37. Describe the judgeship you seek (i.e. geographic area, types of cases, number of judges, etc. and explain how your selection would impact the court. *(150 words or less)*

The 17<sup>th</sup> Judicial District is comprised of Bedford, Lincoln, Marshall, and Moore counties. There are two (2) Circuit Judges and one (1) Chancellor. The judgeship I seek deals traditionally with criminal cases. Presently, several murder cases are active as well as other cases involving, but not limited to: prescription drugs, illegal narcotics, burglaries, thefts, forgeries, vehicular homicides, and felony DUIs.

I have tried numerous Circuit level cases and handled General Sessions Court. From 1998 to 2007, I prosecuted cases in Lincoln and Marshall counties. From 2007 to the present, I prosecuted cases in Bedford, Lincoln and Moore counties at least four (4) days a week. My familiarity and excellent working relationship with the Courts, clerks, officers, etc. in all four (4)

counties combined with my eight (8) years as a Sheriff's Deputy provides me with a unique prospective of a case from arrest to trial.

38. Describe your participation in community services or organizations, and what community involvement you intend to have if you are appointed judge? *(250 words or less)*

I am an active member of the Washington Street Church of Christ. I tithe and serve communion for services and at times serve communion to the bed bound members at two (2) local nursing homes. I am an active member of the Kawanis; Masons; American Legion; Shelbyville Vietnam Era Veterans and Other Vets Group; and the Veteran's of Foreign Wars. As a member of these groups, I attend meetings throughout the District. I serve as an officer for the Masons. I served as a member of the board of directors for Hannah's House – a domestic violence shelter, and I was the representative for the DA's office at Junior's House – a child advocacy center. I have made presentations at the following organizations regarding legal and military events: Marshall County Farm Bureau; Marshall County Republican Women; United Auto Worker's Retiree's Seminar; Spring Hill Seniors Group; Kawanis; and Lewisburg Rotary Club.

My wife, Amy, and I financially support the Fayetteville branch of the Imagination Library; Junior's House; the Carriage House Players (a local theater group); the Lincoln County Museum; the Nashville Rescue Mission; the Wounded Warrior Project; the Nashville School of Law; Boy's Town; Agape; and the ASPCA. My wife and I believe in giving back to both our church and community. To us, giving is a part of being productive members of society.

If appointed Judge, I plan to continue my involvement with these church and community organizations with my interest, participation, and donations.

39. Describe life experiences, personal involvements, or talents that you have that you feel will be of assistance to the Commission in evaluating and understanding your candidacy for this judicial position. *(250 words or less)*

Having served as both a Deputy and as an ADA, I have gained an understanding of how the criminal justice system works from an arrest to the trial of a matter. I have an understanding as a first responder and as a prosecutor of the impact a crime has on the victims and their families, and the emotional roller coaster they experience during all the stages of the prosecution of a crime.

As a prosecutor, I make numerous decisions on a daily basis as to how and to what extent cases should be prosecuted. The decision process includes consulting with law enforcement officers, victims, defense attorneys, victim and child advocates, mental health professionals, family counselors and other government agency personnel. It is my goal to ensure both the victim and defendants are treated fairly and equally under the law.

I have taught many in-service courses for law enforcement agencies within the 17<sup>th</sup> Judicial District. I served in numerous leadership positions within the Army National Guard. Two such examples are Company Commander in Iraq and the current position I hold as a Battalion Executive Officer. I have completed senior staff courses in leadership. In the positions I have held and currently hold, I have to make difficult decisions on a regular basis - sometimes with limited information and time. I have counseled and/or disciplined soldiers for poor performance, drug and alcohol abuse, violations of the code of military justice to include Article 15 (non-judicial punishment), and court martial.

40. Will you uphold the law even if you disagree with the substance of the law (e.g., statute or rule) at issue? Give an example from your experience as a licensed attorney that supports your response to this question. *(250 words or less)*

Yes, I will. An example of my doing so is as follows: Approximately ten (10) years ago a city within the 17<sup>th</sup> Judicial District annexed a small strip of land along a state road until an interstate exchange was reached. The annexation included several small businesses and a small strip of I-65. Once this was completed, the police began to monitor traffic on I-65 and to write speeding tickets. On one occasion, the Chief was monitoring traffic and a vehicle traveling north passed him at a high rate of speed and he pursued. The chase lasted for approximately 30 minutes and 40 miles. The driver was arrested after she was caught in heavy traffic near Cool Springs Mall. Personally, I did not agree with the tactics of enforcing the traffic laws on the interstate, but due to the annexation, the police department was allowed to enforce the traffic laws on the interstate. Although I did not agree with what the law allowed the city police to do, I prosecuted the defendant to the extent of a jury trial at which she was convicted of multiple felonies and is now a convicted felon. During this entire process, I never allowed my personal judgment or beliefs to become involved in my decision making process.







ORDER PLACING DEFENDANT ON PROBATION PURSUANT TO  
TENNESSEE CODE ANNOTATED §40-35-313

This cause having come before the Court and being heard on the 13<sup>th</sup> day of December 2006, and came the State of Tennessee, by and through it's representative, the Office of the District Attorney General, and the defendant, in person with his attorney of record, the Honorable Ray Fraley.

Therefore, IT IS HEREBY ORDERED by the Court that the defendant be placed on probation pursuant to Tennessee Code Annotated §40-35-313 and the court will defer the entry of judgment for a period of six (6) years from the filing of this Order. The defendant shall be on supervised probation for the full six (6) years. The Defendant shall observe the following conditions during the period in which this prosecution is suspended:

1. He shall procure consent of the probation officer before changing his address or employment or before leaving the county of his residence or State for an extended period.
2. He will make full and truthful report to the probation officer in person and/or in writing as directed.

3. He shall not use intoxicants of any kind to excess including lawful use of narcotic drugs. He shall not visit any place where intoxicants or drugs are unlawfully sold, dispensed or used. He shall have no excessive use of alcohol.
4. He shall not associate with any persons of ill repute. He shall report all arrests, to include traffic violations, regardless of disposition to the probation officer in a timely manner.
5. He shall allow the probation officer to visit his home, employment site, or elsewhere and carry out all instructions given by the probation officer whether oral or in writing.
6. If at any time it is necessary to communicate with the probation officer and he is nonaccessible, the Defendant shall direct his communications to the District Director or Regional Director.
7. He shall obey the laws of the United States and any state, county or municipality in which he may be.
8. He shall be liable for all costs imposed by the Court in connection with this case. He shall pay cost of \$422.50, at a rate of \$10.00 per month beginning the first month.
9. He shall conduct himself in a manner consistent with good citizenship.
10. He shall pay the amount of Ten (\$10.00) Dollars per month as compensation for services rendered by the State Probation Department, and any meetings with the probation officer will be determined by the probation officer.
11. The Defendant shall remain employed full time.



12. The Defendant shall surrender his driver's license and shall agree to an order by the Court that Defendant's driving privileges be revoked for a period of six (6) years from the date this order is entered.
13. The Defendant shall attend and complete a driver's improvement/training program for persons with mental disability. He shall pass all requirements set forth by the driver's improvement/training program, and he must obtain a letter from the instructor and/or director of such program verifying that he has complied with all the requirements of said program. The letter shall state he is a competent, safe driver and does not pose a risk to other motorists who use the streets, highways and areas frequented by the public before he attempts to obtain and/or obtains his driver's license at the completion of his probation. The aforesaid driver's improvement/training program will be at the expense of the defendant; Probation Officer must approve such driver's program.
14. The Defendant sentence shall be six (6) years.

Upon successful completion of his probation, all cases against the defendant shall be dismissed, and the defendant shall be allowed to expunge his records in accordance with TCA §40-35-313.
